teTeX security update (RHSA-2007-1028)

## 1. Overview:

TeX is a TeX distribution for UNIX ® and UNIX-like systems.

TeX was found to contain a flaw in handling malicious PDF files that could potentially cause TeX to crash or execute arbitrary code. The Common Vulnerabilities and Exposures project ([cve.mitre.org](http://cve.mitre.org)) has assigned the name [CVE-2007-5393](https://cve.mitre.org/cve/2007/5393) to this issue.

No Avaya system products are vulnerable, as TeX is not installed by default.

## 3. Avaya Software-Only Products:

Avaya software-only products operate on general-purpose operating systems. 	affected package may be installed on the underlying Operating System supporting the CVLAN application. The CVLAN application does not require the software described in this advisory.
Avaya Integrated Management Suite (IMS)	Depending on the Operating System provided by customers, the affected package may be installed on the underlying Operating System supporting the IMS application. The IMS application does not require the software described in this advisory.

### **Recommended Actions:**

In the event that the affected package is installed, Avaya recommends that customers follow recommended actions supplied by RedHat Linux.
