Summary

Continuing the Avaya Aura R6 Lifecycle plan, Avaya is announcing the End of Sale of Avaya Aura R6 License Add (Expansion) and Uplift and Aura Session Manager Connection licenses.

(Note Call Center Elite R6 Add (Expansions) continue to be available).

This follows the previously announced End of Sale (EoS) of New and Upgrade for Avaya Aura® R6 Suites, R6 Analog, R6 IPT Basic/Enhanced, Session Manager and Call Center Elite Licenses, as well as Avaya Aura R6 New Survivable Remote Sites ie Local Survivable Processor (LSP) inclusive of the Branch Session Manager (BSM) and Additions of Communication Manager R6 ESS and Duplex capability and End of Manufacturer Support for Avaya Aura® R6 and Call Center Elite R6. (also covered in this EoS document) and previous <u>EoS of Communication Manager R6 Standard Edition (SE), Enterprise Edition (EE) User</u> <u>licenses and Avaya Aura Suites Version 1 for New and Upgrades</u>.



Buy to Current offer does NOT change the natural lifecycle of a software release. With the End of Sale (availability) of each of the R6 transactions, order tools will only offer Avaya Aura® Current Release offer.

For example: when Aura R6 goes EoS for New and Upgrades the order tools will no longer offer R6 as a BTC option for New and Upgrades.

When Aura R6 goes EoS for Adds/Uplifts the order tools will no longer offer the option to purchase at R7 and deploy as R6. Systems that are currently in Aura R7 Buy to Current but deployed as Aura R6 w ill need to deploy their R7 (or upgrade to 8) to continue to Add capacity (capacity would be added at the R7 level).

These solutions have been superseded by new releases.

All End of Sale and End of Manufacturer support listed apply to both Commercial and Federal customers.

Effective July 9, 2018, Avaya will no longer make available Avaya Aura® R6 License Add (Expansion) and Uplifts. This also is the end of sale of the remaining R6 Session Manager Connection Licenses.

This includes Avaya Aura R6 Add Licenses for Standard Edition (SE), Enterprise Addition (EE), Analog, IPT Basic, IPT Enhanced, Foundation Suite, Core Suite and Power Suite and the Session Manager Connection licenses. Avaya Aura R6 License Uplifts (in release level uplift from one license level to another) are also End of Sale; this includes uplifts to SE, EE, IPT Basic, IPT Enhanced, Foundation, Core and Power. This is the final Avaya Aura R6 Lifecycle event, as of July 9, 2018 Avaya Aura R6 will be fully End of Sale and End of Manufacturer Support.

Avaya Extended Support Services for Avaya Aura®6 remains available, per Lifecycle policy https://downloads.avaya.com/css/P8/documents/100081098.

When Aura R6 goes EoS for Adds/Uplifts the order tools will no longer offer the option to purchase at R7 and deploy as R6. Systems that are currently in Aura R7 Buy to Current but deployed as Aura R6 will need to deploy their R7 (or upgrade to 8) to continue to Add capacity (which will be added at the R7 level). Avaya recommends customers upgrade to current manufacturer supported release for business expansion and to benefit from the new business values and to maintain the support and security levels their business demand.

Effective July 9, 2018, Avaya Aura[®] R6 and Call Center Elite R6, will be End of Manufacturer Support (EoMS)

Per <u>Lifecycle Policy</u>, EoMS of a Major Software release occurs roughly 12 months after End of Sale (EoS) of that release New and Upgrade transactions which, for Avaya Aura[®] R6, occurred June 12, 2017. <u>EoMS</u> means there will be no further manufacturer design support for Avaya Aura[®] R6; this includes Service Packs/Bug Fix/Patches and Security Updates.

Avaya Extended Support Services for Avaya Aura®6 remains available, per Lifecycle policy <u>https://downloads.avaya.com/css/P8/documents/100081098</u>.

Avaya recommends customers upgrade to current manufacturer supported release to benefit from the new business values and to maintain the support and security levels their business demand.

Effective January 8th, 2018, Avaya will no longer make available

- <u>New R6 Sites/ Local Survivable Processor (LSP) including the Branch Session Manager (BSM)</u>
- Addition of R6 ESS or Duplex options to an existing R6 system

Customers requiring:

- New site capacity in the form of LSPs may order a Avaya Aura[®] R7 LSP and add it to the existing Avaya Aura[®] R6 core system. Contact ATAC for ordering directions.
- To add ESS to an Existing Avaya Aura R6 system may order a R7 ESS solution and add it to the existing Avaya Aura® R6 core system. Contact ATAC for ordering directions.
- To add Duplex to an Existing Avaya Aura[®] R6 Simplex system will need to upgrade and deploy at Avaya Aura[®] R7 level. Avaya Aura[®] R7.1 introduced enhancements that now allow CM Duplex systems to be physically separated. See Section 5.4.14 of the <u>Avaya Aura[®] R7.1 Offer Definition</u>.



<u>Effective June 12th, 2017</u>, Avaya will no longer make available R6 Suites licenses for <u>New systems or</u> <u>system Upgrades</u> (inclusive of entitled upgrade, paid upgrade, upgrade/move, upgrade/uplift, upgrade/uplift/move, upgrade/ASIPP migrate transactions).

All new systems or upgrades are available in the most current release.

<u>Buy to Current offer</u> does not change the natural lifecycle of a software release. With the End of Sale (availability) of R6 New and Upgrades, order tools will only offer Avaya Aura[®] R7 for new and upgrades until the next major release becomes available.

Upgrade Move/Merge and ASIPP migrations are upgrades <u>not</u> add/expansion and are therefore part of the New and Upgrade End of Sale

Other Transactions:

- **Communication Manager Base Stations Adds** included as part of Avaya Call Center bundle offers such as AES DMCC Full, WFO, AEP EMC continue to be available as part of the associated product bundle. Expectation is these will end of sale Mid 2019.
 - Systems must be on or updated to minimum release level of CM 6.3.118 Load 141 and if applicable System Platform R6.4
 - CM Base Stations cannot be leveraged or uplifted for User Capacity
- Capacity Add / Expansions for <u>existing Call Center Elite R6</u> systems continue to be available until an official End of Sale is published. See <u>Schedule Section</u> for target timelines.
 - Systems must be on or updated to minimum release level of CM 6.3.118 Load 141 and if applicable System Platform R6.4
 - See Options to Continue to Add R6 CC Elite agents to an existing Avaya Aura System
- Session Manager Connection for CS1K solutions; these will EoS when CS1K EoS
- Consolidations (move/merge) for Avaya Aura[®] and Call Center Elite R6 systems continue to be available until an official End of Sale is published

Options to Continue to Add R6 CC Elite Agents to an existing Avaya Aura system

It is recognized that a customer's CC Elite environment may be delayed in upgrade because of 3rd party product interactions, which is why CC Elite does not necessarily EoS a specific release Add the same time as the Aura Add EoS. As of July 9, 2018 you <u>can</u> purchase the CC Elite R6 ADD Agent Licenses but <u>cannot</u> purchase a R6 UC license to support it. (UC licenses are not bundled with the CC Elite license) Systems must be running minimum release level of CM 6.3.118 Load 141 and System Platform R6.4

Choices if you foresee R6 CC Elite Agent capacity requirements past July 9, 2018 are:

 Even though CC Elite and Aura CM are technically the same software base, you <u>can run a CC</u> <u>Elite R6 license on an Aura CM upgraded and deployed as R7 or R8</u>. So if the customer is not ready to upgrade the CC Elite specifically, you can upgrade and deploy the Aura CM to current (R7 or 8) but keep the CC Elite running as R6. This way you would Add your Aura UC licenses at the R7 or R8 level to support the CC Elite Agent Capacity but can still add your CC Elite at R6 level.



- 2) If the customer wants to keep the Aura CM running at R6 ... the options for future capacity of CC Elite R6 are:
 - a. Does customer have excess capacity of R6 UC licenses on the system to support the CC Elite capacity needs (<u>*see Licenses not available for use with CC Elite Agents</u>)
 - i. They can use that capacity to support CC Elite R
 - If they have excess UC licenses on other systems that are R6, they can move them to the system adding CC Elite capacity Must meet Consolidation Guideline requirements
 - b. If they do not have available R6 UC license capacity, they can Last Time Buy their Aura R6 Add licenses before the July 9, 2018 to support anticipated R6 CC Elite capacity growth until they upgrade the Aura to current release. The license would remain in their PLDS records for use at any time. This license would be part of the volume you would need to include as part of your Aura upgrade to current design.

* The following Licenses are not available to use for CC Elite Agents

Analog Stations, IPT Basic, IPT Enhanced

or "CM Base Stations"; Base Station are not an orderable item and are only deployed as part of another service such as DMCC Full. They cannot be leveraged for User Capacity
