# Application Notes for Jabra BIZ 2300 Mono/Duo USB-A/USB-C Headset with Avaya Agent for Desktop - Issue 1.0

### **Abstract**

These Application Notes describe the configuration steps required to integrate the Jabra BIZ 2300 Mono/Duo USB-A/USB-C Headset with Avaya Agent for Desktop. Call control is supported by the Jabra SDK which is inbuilt into Avaya Agent for Desktop.

Readers should pay attention to **Section 2**, in particular the scope of testing as outlined in **Section 2.1** as well as any observations noted in **Section 2.2**, to ensure that their own use cases are adequately covered by this scope and results.

Information in these Application Notes has been obtained through DevConnect compliance testing and additional technical discussions. Testing was conducted via the DevConnect Program at the Avaya Solution and Interoperability Test Lab.

### 1. Introduction

The Jabra BIZ 2300 Mono/Duo USB-A/USB-C Headset allows connection and call control with Avaya Agent for Desktop (hereafter referred to as Agent Desktop) using cable via the USB interface to the PC. Call control is supported by the Jabra SDK which is inbuilt into Avaya Agent for Desktop. In these compliance test, Jabra BIZ 2300 headset USB-A and USB-C connection are used.

With a Jabra headset connected to the PC USB interface, users can directly answer, end, mute/unmute, hold/resume and adjust volume using the in-line call controller of the headset with Agent Desktop running on the PC.

# 2. General Test Approach and Test Results

The interoperability compliance test included feature and serviceability testing. The feature testing focused on placing calls with Agent Desktop, answering and ending calls using the call control button on the Jabra headset, and verifying two-way audio. The call types included calls to voicemail, local extensions, and the PSTN. Call hold and resume, mute and un-mute, and volume are also tested.

The serviceability testing focused on verifying the usability of the headset solution after restarting the Agent Desktop, restarting the PC, and reconnecting the headset USB cable to the PC.

DevConnect Compliance Testing is conducted jointly by Avaya and DevConnect members. The jointly-defined test plan focuses on exercising APIs and/or standards-based interfaces pertinent to the interoperability of the tested products and their functionalities. DevConnect Compliance Testing is not intended to substitute full product performance or feature testing performed by DevConnect members, nor is it to be construed as an endorsement by Avaya of the suitability or completeness of a DevConnect member's solution

For the testing associated with these Application Notes, the interface between Avaya systems and endpoints utilized enabled capabilities of TLS/SRTP.

Avaya's formal testing and Declaration of Conformity is provided only on the headsets/handsets that carry the Avaya brand or logo. Avaya may conduct testing of non-Avaya headset/handset to determine interoperability with Avaya phones. However, Avaya does not conduct the testing of

non-Avaya headsets/handsets for: Acoustic Pressure, Safety, Hearing Aid Compliance, EMC regulations, or any other tests to ensure conformity with safety, audio quality, long-term reliability or any regulation requirements. Since there is no industry standard for handset interfaces, different manufacturers utilize different handset/headset interfaces with their telephones. ## 2.1. Interoperability Compliance Testing

All test cases were performed manually. The following features were verified:

- Placing calls to the voicemail system. Voice messages were recorded and played back to verify that the playback volume and recording level were good.
- Placing calls to internal extensions to verify two-way audio.
- Placing calls to the PSTN to verify two-way audio.
- Answering and ending calls using the call button on the in-line call controller of the headset and the soft button on Agent Desktop.
- Using the hold button on the in-line call controller of the headset and the soft button on Agent Desktop to hold and resume the audio.
- Using the volume buttons on the in-line call controller of the headset to adjust the audio volume.
- Using the mute button on the in-line call controller of the headset and the soft button on Agent Desktop to mute and un-mute the audio.
- Verifying incoming call notification on the in-line call controller of headset.
- Verifying call ended notification on the in-line call controller of headset.

The serviceability testing focused on verifying the usability of the headset solution after restarting the Agent Desktop, restarting the PC, and reconnecting the headset cable to the USB interface of the PC.

#### 2.2. Test Results

All test cases are successfully completed. The following are the observations made:

• In *Advanced Audio Settings* for Agent Desktop, if *Headset Integration* is set to Advanced (SDK Native) the call button on Jabra BIZ 2300 headset can performed both Answer/Drop call function.



**Figure 1** illustrates the test configuration used to verify Jabra BIZ 2300 Mono/Duo USB-A/USB-C headset with Agent Desktop. The Avaya Agent for Desktop software was installed on the PCs. The Jabra headsets are connected via cable to the PCs' USB interface.

# 5. Configure Avaya Aura® Communication Manager

This section covers the station configuration for Agent Desktop on Communication Manager. The configuration is performed via the System Access Terminal (SAT) on Communication Manager.


Using an existing H.323 station, add the feature buttons shown in bold, which are used by Agent Desktop to log in as an Automatic Call Distribution (ACD) agent.

# 6. Configure Avaya Aura® Session Manager

This section covers the station configuration for Agent Desktop on Session Manager. The configuration is performed via the System Manager.


Using an existing SIP station, administer the feature buttons required. On the System Manager, navigate to User Management > Manage users > New User Profile > Communication Profile > CM Endpoint Profile > Endpoint Editor. At the bottom of the page, click the Button Assignment tab. Assign the manual-in, auto-in, after-call, agnt-login and aux-work button. Configuring these buttons is required to sign in the agent in Agent Desktop.




# 7. Configure Avaya Agent Desktop

Simply plug the Jabra BIZ 2300 cable into the USB port of the PC. The device drivers will automatically be installed. In these compliance settings, local configuration for Agent Desktop is used.

After logging into Agent Desktop, select **Settings** as shown below.




In the **Avaya Agent Settings** window, click on **Audio** and check that the **Device** under **Audio Output** and **Audio Input** display *Jabra BIZ 2300*. Otherwise, select the device from the click down menu on the respective box. The **Ringer Output Device** selection of *Jabra BIZ 2300* as **Device** is optional.



Scrolling further below for **Advanced Audio Settings**, select **Control Device** as *Jabra BIZ 2300* and **Headset Integration** as *Advanced (SDK Native)* which enables the advanced headset feature. If the **Headset Integration** is selected as *Basic (HID API)*, the call button can only performed one function i.e. answer, hold or drop.


Click **Save** to complete the audio settings.



# 8. Verification Steps

This section verifies that the Jabra solution has been successfully integrated with Agent Desktop PC.

- 1. Make incoming and outgoing calls and verify that calls can be established with two-way audio. For incoming calls, answer the call by pressing the call button on the in-line call controller of the headset (as shown below).
- 2. End the call by pressing the same call button on the in-line call controller of the headset.
- 3. Verify also that the headset is able to remotely control call functions such as answer, mute/un-mute, hold/resume and adjust the volume on the in-line call controller. Call Hold is done by pressing the call button once. Pressing the call button again will resume the call. Similarly, verify such call control functions could be done on the Agent Desktop.



## 9. Conclusion

These Application Notes describe the configuration steps required to integrate Jabra BIZ 2300 Mono/Duo USB-A/USB-C Headset with Avaya Agent for Desktop. All test cases were completed successfully with observations noted in **Section 2.2**.
