Standard extension to continue through product EoL.

# **Background:**

This notice announces the manufacture discontinuation of the Nortel Switched Firewall and Standalone Firewall families of hardware and software products.

#### Analysis:

Manufacture Discontinue (MD) - This notice serves as formal communication of Nortel intent to MD the products noted. No further orders will be accepted after the Last Time Order Date shown below. The MD of these products is not the discontinuance of support for existing field population of devices. Services to the installed base will continue to be provided until the End of Life (EOL) date shown below.

Last order date for Nortel Switched Firewall products is September 30, 2009.

Hardware MD: September 30, 2009 Software MD: March 31, 2011 Product EOL (hardware and software): September 30, 2012

Product Support Milestone Dates: Hardware maintenence: Until September 30, 2012 Software maintenance: Until March 31, 2011 Software support services (technical assistance and troubleshooting, best effort basis): Until September 30, 2012

Full product EOL will be Sept 30, 2012. No support available after that date.

# **Recommendations:**

Nortel will not be offering a replacement product for the Nortel Switched and Standalone Firewall products. Customers should plan to replace these products with an

equivalent product from Checkpoint. Checkpoint will assist customers in determining the best replacement product and may offer trade in allowances. Customers should work directly with Check Point or a Check Point reseller on this migration.
