

# 1408 and 1416 Digital Desk phone Release 4 Service Pack 4 Readme

This is the Readme file for Release 4 Service Pack 4 (Alias Release 38, Vintage 7) of the Avaya 1408 and 1416 Digital Desk phone software.

The 1408 and 1416 telephones can be upgraded via Avaya Aura<sup>™</sup> Communication Manager Release 5.2.1 or later.

The reason for Service Pack 4 for Release 4 is an accumulative release that contains fixes from all prior releases.
