## **ACM EoMS Alignment**

ACM is extensively used for configuration of One-X Agent. Current EoMS date for ACM is 04-Jan-2026. Admin Portal has all the capabilities to support One-X Agent configuration related tasks. EoMS date of ACM does not impact One-X Agent. There is a 2-year runway and no gaps (functional parity and workaround) in Admin Portal.

#### **Migration Strategy**

Existing systems can continue to add Avaya One-X Agent seats until the end of Manufacturer Support.

Agent for Workplace (3.3x): For existing customer only preferring desktop client and for On Prem deployment

- For Subscription customers, Agent for Workplace is part of the CC Voice bundle as an entitlement.
- For perpetual users with One-X Agent\_Advance licenses, can acquire Agent for Workplace license at no additional cost (409911 AGT FOR WORKPLACE ASIPP).
- For perpetual users with One-X Agent Standard, can purchase Agent for Workplace license (409910 AGT FOR WORKPLACE NEW / ADD).
