This PSN advises customers and partners that Workplace 3.34 and below release does not support Mac OS 14.0 release. We have observed Workplace client crashes when installed on MacOS current release 14.0 (Sonoma).

Resolution

Workplace 3.35 supports MacOS 14.0. Customer upgrading to MacOS 14.0 should upgrade Workplace release to 3.35. Workplace 3.35 release for MacOS is planned to be GA on 31st October '23.
